- 1) Historic sites can be hazardous. Please take care.
- 2) One pass is issued to each household/adult resident. Passes and gate cards are non-transferable and can only be used by the named resident and up to 4 accompanying children.
- 3) Children under the age of 16 must be accompanied by an adult at all times and must be kept under close supervision.
- 4) Wilful damage to the monument is an offence. This includes climbing, ball games, sledding, digging etc.
- 5) Unauthorised use of metal detectors is an offence.
- 6) Commercial photography and filming are prohibited without the prior written consent of English Heritage Trust.
- 7) The flying of drones and other remote aircraft is prohibited without the prior written consent of English Heritage Trust.
- 8) Dogs must be kept under close control at all times.
- 9) Dog owners must clear up after their animals. Please use the general waste bins provided.
- 10) This pass does not entitle the bearer to free access to English Heritage Trust or third party events. We would advise against accessing the site during such events.
- 11) English Heritage Trust has permission to process and store my personal data.
- 12) If I lose my out of hour's access I understand that I will be charged a small fee to gain a replacement.
- 13) I understand that inappropriate use of this pass may lead to the pass being withdrawn from my possession.
- 14) I understand that English Heritage Trust reserve the right to change these terms and conditions without my prior consent.
